The aim is to detect all event or factor that could mean an operational or brand exposure risk.

Additionally, at the request of the contractor, the report may be supplemented with a Management Evaluation.

Corporate Reputation Report

It is a product intended to provide complete information of commercial counterparts, in order to allow an optimal decision making.

Only public information will be used. No information requirements will be done to the counterpart, in order to guarantee confidentiality. Also records and exposition information are taken into account in the investigation.
